11 (1) Yesterday I received a call from the King Country prosecuting Attorney Dan
Satterberg agent! His assistant prosecuting Attorney Maggi Qerimi who informed
12 me that they had held the inquest hearing into Patrick murder! This by the police
without mine or his mothers Ms Craigs presence! That as the result of the
13 information (presented) at this sham hearing they found the police not guilty of
murdering Patrick and were not going to prosecute them!

14 In our previous conversation I informed her that is exactly what I expected a
15 coverup! Which I had predicted in my motions filed before the courts inquest
hearing! Which was filed as evidence after the county attorney and the judge
16 bared me from taking part of this hearing! As the only free and independent
constitutional pro per attorney and only real prosecutors in this case! It is the
17 custom of lawyers & judges to fix the outcome of cases! If you have additional

18 As all the rest were state bar licence lawyers at this hearing are organs/agents
19 of the government defense attorney for the police, judges and county attorney!
Who's mission it was to hold a sham hearing, to lie about facts an law! To
20 suppress the evidence of the criminal acts in the conspiracy that resulted in
police murdering my son in his own home!

21 One of the most outrageous LIES in this case was made by the judge of this
22 court! When she put in the court's record that Patricks family had the right to
have a lawyer at the inquest hearing but chose not to! The court's records prove
23 that Patricks family had a pro per lawyer in this case who was his father! Who
was more qualified than any of these state bar licences lawyers to present
24 evidence in this case and to prevent a coverup!

25 Who had already exposed the criminal acts that started this case by the
Derheims who were aided and abetted! By their state bar licence lawyer and
26 officer of this court Corry Mc Bride! He had provided to this court and their
attorney that the Kent police Chief Ken Thomas, his department, the Alburn
27 Police, king county

1 attorney Dan Satterberg! An that all the state bar licence lawyers involved in this
2 case were conspiring to obstruct justice, furthering the coverup and fixing the
outcome of this case!

3 The judge at all times knew that I was in fact acting as my own lawyer in this
4 case! She then acted to protect the Derheims and their police agents from the
5 evidence of their criminal conspiracy! That resulted in Patricks murder in his
6 own home! This by ordering that I stop acting as my own attorney at this inquest
hearing! Who then lied about it in the record falsely stating that I had chosen not
to have a lawyer at this hearing! When she at all times knew that I was that lawyer
whom she had bared from this case!

7 Even more outrageous, shocking and illegal was that in order to shut me up
8 from being my own lawyer and a material witness in this case! Was when the
9 county attorney Dan Satterberg in collusion with the king county Washington's
sheriff! Did in a direct act of terrorism, police state actions!

10 Illegally contacted the Los Angeles police department (LAPD)! An without any
11 just cause! Who gave them confidential evidence that I had provided to the
12 inquest courts lawyer! Which I had uncovered while acting as a lawyer in this
13 case! The indisputable evidence that I had given them! Which was that the police
14 while at all times were acting as the agents & enforcers for the Dirhams from the
beginning

15 The facts are that (A) That immideatly after Patricks wife of ten years died of an
16 accidental overdose of drugs! Her parents the Dirhams were advised by their
17 lawyer that Patrick could inherit all of her estate (B) Then they and their lawyer
18 devised to scheme steal Patrick inheritance which we have just learned was
more than a million dollars!

19 (C) Together they willfully committed crime on the probate court and the
20 people of the state of Washington and that of Patrick by submitting False,
21 fraudulent an perjured documents to open an illegal probate case with the intent
22 to steal Patricks inheritance!

23 (D) With this invalid document obtained by fraud upon the court! They
24 immideatly went to the Kent police and had them become their agents! This
25 because they have money, power and influence and Patrick who had none!

26 (E) These professional police at all times knew or should have known that their
27 probate filing was a fraud because he was not listed as an heir which they knew
28 he was!

29 (F) Their excuse to get these police involved was that Patricks who was Amys
30 husband! Who had been living together for ten years as husband and wife was
31 taking illegally money from her account and putting in his! When they had no
32 proof of this fabricated lie! When they both had their bank accounts in the same
33 bank!

34 Further the Dirhams obtained Amys and Patricks personal bank records
35 illegally! As they had obtained an illegal counterfeit probate filing form and by
36 fraud used it to get these private bank records and other crime!

37 Further the Dirhams had no legal authority over the financial of Patrick and his

1 wife Amy! Also, on their face the bank records prove nothing! As Amy was dead
2 and therefor no one could know what their personal banking relationship was!
3 Which the police at all times knew that they had no legal authority too in anyway
4 be involved in this matter even if there were a lawful probate case which they
5 knew it was not!

6 (G) Next to help the Dirhams in their conspiracy to steal Patricks inheritance!
7 These Kent Cops obtained Patricks personal bank records with illegal and back
8 dated search warrants. (To this day his bank has illegally refused to provide this
9 information to his heirs a year later what are they hiding!)

10 (H) The day before the police murdering Patricks murder they were at his home
11 apparently asking him questions on behalf of the Dirhams Family! Regarding his
12 and Amys private banking relationship which was on its face none of their
13 business! There is also no evidence they informate him that he had the right for
14 an attorney!

15 At this meeting they had apparently checked the records and saw that they
16 were in no danger as he had no gun! Therefor why did they bring out their heavily
17 armed swat team the next day only to serve a warrant for his computers and then
18 attempted to kick down his door and he did not shoot these gagsters!

19 (H) The Kent police then further conspired with the Dirhams to violate Patricks
20 rights depriving him of any legal counsel While typing up search warrants in their
21 back room! Then using their illegal search warrant to come to his home for the
22 stated purpose which was to steal his computers and records and then back
23 dated its filing!

24 This In an effort to destroy his home based computer business! When even on
25 their search warrant they stated their computer expert was out of country for
26 three weeks and could not access any data in the files! Newly discovered
27 evidence indicates that in his computer and his records could contain her will
28 making him the sole heir to her estate!

Also their marriage licence and further information on Patrick belief that the
Dirhams were involved in Amys death! Which occurred just after she had
returned from parents home in Arizona before her death? The police killed him
steals his computers and his records! An now a year after his death they have
still refused to return this evidence to Patricks heirs what are they hiding!

(I) The facts are that the police were illegally at Patricks home without a lawful
search warrant! An even after they acting like police state gangsters attempted to
kick down his door to his home. Whose disturbance woke him up as he was
sleeping in his bed room! He then came to his door and peacefully with only his
pajamas on let them in his home!

(I) Then like a maffia hit they shot him point blank range and murdered him!
An the coverup began the cops first lie was to tell the media that he came to the
door with a gun in his hand and they shot him!

Then they said that after he let these cops in his very small living! With one
who had his gun drawn! That out of the air he produced a gun but shot no one!
These cops however with a fabricated search warrant while being in his own
home! One cop shot him several times and he then fell to the floor.

1 These cops then lied and alleged that when he fell to the floor mortally wounded!
2 That by some miracle that he was able to while falling put the gun in both hands
3 and keep them there after falling. However the problem is that my excerpts have
4 informed me that when a person who has been shot by reflex drops everything in
5 their hands to break their fall!

6 These cops however at that point being only inches away from this mortally
7 wounded citizen in his own home! Now claimed that Patrick has kept both hands
8 on this gun. Therefore even if true they could have easily taken the gun away
9 from this defenseless person! Who was never known to have a gun or even how
10 to use one!

11 While I was well trained with the use of a gun being a veteran and Military police
12 and a total supporter of the second amendment for protection of our nation! For
13 safety reasons I never had a gun in my home for safety reasons or had Patrick in
14 any way involved with them!

15 Therefore, instead they like murder incorporated filled him up with SIXTEEN
16 deadly bullet's at point blank range and murdered him as the agents of the
17 Dirhams! Then as part of their coverup they alleged that the gun was purchase by
18 him!

19 As it is a known policy by the police to suppress the truth plant guns, evidence
20 and have been proven to be pathological liars. For that reason I requested from
21 the courts lawyer, an the county attorney! That they formally confirm that he had
22 in fact purchased this gun from a licenced gun dealer for this hearing which they
23 refused to do!

24 (J) The coverup and acts of obstruction of justice continued in just three days
25 after Patrick murder! When the police illegally gave their criminal co conspirators
26 the Dirhams family's daughter the keys to Patricks home! Which they had no
27 lawful authority to have access to or be able to enter! As when Amy his wife died
28 he was in sole possession of his home and all property therein!

As this point Patricks home under law was now the sole property of Patricks
heirs and were the only ones who were to be allowed access. However the police
never contacted his heirs for a longtime after they gave their crime partners
access and total control of his home! His home as per the police record was the
crime scene for three different cases (1) Amys death (2) Patricks Murder By
their Kent police (3) Amys and Patricks Bank Records! (WHY THE RUSH)

(K) Having illegal access to Patricks home the Dirhams their family and agents
begin to cleanse (rob his) home of all his property. records copies of her will,
marriage contract, bank accounts, business records, money, stocks, bonds and
life insurance policy's Ect! Who to this day have refused to provide list of his
property and what they have done with it!

(L) After the police gave their bosses the Dirhams the criminal access to Patrick
home while his heirs were excluded! Where they continued their conspiracy to
steal his inheritance and that of his heirs. With their continues criminal acts
which includes the brazen theft of his personal property!

1 As patricks heirs at this point we did not know of the police total involvement
2 with the Dirhams in their murder of Patrick and their coverup. Therefore when we
3 learned that they were stealing or illegally disposing of Patricks property and
4 records ect!

5 We made many complaints to the Kent, Auburn police and the county
6 prosecuting attorney of these further and traditional criminal acts! Including the
7 missing property in the storage pod at his home! That the police saw on the day
8 that they acting as agents of the Dirhams murdered him! They resolutely refused
9 to investigate these crimes, recover stolen property or bring their crime partners
10 to justice!

11 (M) When i discover that the Kent and Alburn police were conducting a sham
12 investigation into the police murder of Patrick! I filed with their departments a
13 request that as the result of their conflict of interest! That they remove
14 themselves from this case and appoint an impartial investigator they refused!

15 (N) I them made many request to the king county prosecuting attorney about
16 these crimes and cover up! He did nothing more than to notify them of my
17 complaint! Furthering the coverup and obstructing justice who however did not
18 inform the county's sheriff of these crimes!

19 As he did when he attempted to shut me up by threatening my personal safety
20 and security! When I exposed this greatest possible betrayal of their oath of
21 office and public trust! With the police murder of Patrick and their coverup!

22 (O) Further we kept demanding from the Dirhams and their lawyer Corry Mc
23 Bride that they provide us of the list of property that was in Patricks home when
24 they obtained illegal possession of his home! From their co-conspirators and
25 partners in crime the Kent police department without the knowledge or
26 permission of Patricks heirs!

27 The sole lawful residences at his home! So that we would know what was
28 required to have his property collected and transported to his heirs in a different
state they refused to provide us with this list!

(P) Then the Dirhams through their lawyer Corry Mc Bride ordered Patricks
heirs that they had to remove from their property (Patricks home) his car and
remaining property now only a few small boxes! With only a few of his clothes
and a few of his personal belongings left!

Which they had not stolen or illegally deposed of before the end of that
weekend was over! If not that they would sell his car and depose of his remaining
property! Upon receiving these threats his heirs called the Alburn, Kent police
and county prosecuting attorneys for legal protection which they refused!

(Q) Under duress, and great expense of time and money his heirs were able to
locate a private company n king county! To go to his residence pick up his car
and the few remaining items of his personal property! An move to a safe storage
place away from his home.

Which was further complicated by danger to their personal safety and security!
By the fact that the Kent police department who had murderer Patrick at his home
wanted to be their when his heirs picked up his property!

1 Being concerned as to what was the sudden urgency of this forced move his
2 heirs googled this address! To their shock they discovered that with the aid and
3 protection of the king counties legal establishment! They had stolen Patricks
4 home & in secret sold it! While the police & county prosecuting attorney have
5 done nothing to uphold the law or bring these criminals to justice they just
6 furthered their coverup!

7 (R) Shortly after Patricks murder I discovered that the Dirhams had conspired
8 to steal Patricks inheritance by filing with the probate court a false and fabricated
9 claims that they were Amys sole heirs which on its face was an indisputable
10 fraud! Who then made the Kent police their agents in their fraud and criminal
11 conspiracy.

12 Uncovering this criminal act a motion was filed with the probate court in this
13 regard the court took no action depriving his heirs of due process an equal
14 protection of law! As well as damaging the court's integrity, and credibility the
15 court joined this conspiracy and coverup and to no action!

16 (S) When these violation of law continued non stop with the Dirhams! Then I
17 filed new motions with the court with indisputable evidence that the Dirhams and
18 their lawyer Corry Mc Bride were involved in Fraud and Criminal contempt of
19 court! Then the judge in this probate case in the outrageous violation of law
20 became a willing accessory instead and did not bring them to justice! !

21 But dismissed my complaint with an outrageous lie and fraud upon the court!
22 When he said that I had filed no motions in this case! When the courts own
23 docket proves otherwise! Further complaints of this betrayal and treasons acts
24 were filed with other judges in this court! Who just furthered this obstruction of
25 justice and the coverup of the criminal acts of the lawyers acting as judges in this
26 court as the record proves!

27 THE INDISPUTABLE PROOF OF THEIR CRIMES!

28 The shocking facts are is that in America we have been betrayed by our elite
and their legal establishment! Who have also militarized the police given them the
police state authority to murder any defenseless people that they considered
deplorables and undesirables!

Because they thought Patrick was in this category as he was just a middle
class person with no legal experience or backup in Washington state! Therefore
the police thought that he was defenseless and expendable! As they did not know
of myself or my personal experience in legal matters!

I Immedeatly upon learning of his murder by a call from his distraught mother I
began an investigation into the facts and evidence into his killing in his own
home. Immedeatly I knew there was problem as I caught the police in lies,
stonewalling , and obstructing my investigation!

As the result of my numerous complaints in this regard! The government
officials in king county decided to hold an inquest investigation into the murder
of Patrick by the Kent police! Who had murdered him and then became involved
in a extensive coverup!

1 **I Became The Sovereign Pro Per Attorney!**

2 **Having been contacted by the King counties prosecuting attorney lawyer Maggi**
3 **Qerimi! Who informed me that she was the attorney for the court in this inquest**
4 **hearing! That her job was to investigate and submit to the court the evidence**
5 **regarding Patricks killing! She told me that I could have a lawyer represent my**
6 **interest in this case! I informed her that I was going to act as my own lawyer!**

7 **I then been working with her like a co counsel for this hearing! As I was**
8 **involved with my investigation months before the appointment of this inquest**
9 **court! I began sharing with lawyer Maggi Qerimi an her document researcher Ms**
10 **Meghan Moore the information that my investigation had uncovered!**

11 **They also provided me with discovery which I then spent hours reviewing! Then**
12 **I provided them with additional information and the names of additional witness**
13 **needed for this hearing! While informing them where additional evidence could**
14 **be found in the governments files and where other information could be**
15 **subpoenaed!**

16 **In the process I also provided them with the indisputable evidence that this**
17 **case was started as a criminal conspiracy by the Derheims! Who purpose was to**
18 **steal Amys inheritance from Patrick! Which we have just learned was worth**
19 **more than one million dollars!**

20 **That was started by them when they filed a fraudulent probate case in which**
21 **they committed perjury when they stated that they were Amys sole heirs! This**
22 **filing was rubber stamped by the probate court when they knew or should have**
23 **known! That Patrick was Amys heir by the many news reports stated that they**
24 **were living together for ten years as husband and wife!**

25 **The judge oked this fraudulent filing without any verification of the truth in**
26 **their filing! An Immideatly after Amy death the Derheims joined in a conspiracy to**
27 **make the Kent police willing their agents! Who at all times knew that the probate**
28 **filing was a fraud, illegal, devoid of actual authority!**

29 **However they became the henchman of the Derheims their agents who**
30 **conspired to attack and destroy Patrick who was defenseless! Which resulted in**
31 **his murder and its extensile coverup! Which indisputable evidence was provided**
32 **to the court's inquest prosecuting attorney who has sworn to uphold the**
33 **constitution, due process and equal protection of law!**

34 **However what I did not know was that lawyer Maggi Qerimi was in fact at all**
35 **times the agent of the county prosecuting attorney Dan Satterberg. Who was the**
36 **protector of the police! As was the lawyer acting as judge who as their custom**
37 **in police shooting of civilians! Was to conduct a show trial to deceived the**
38 **people while my investigation an evidence!**

39 **Made this impossible so they had to get rid of me! I seeing that the courts**
40 **attorney had not produced additional discovery required for a real evidentiary**
41 **hearing! An that addition material witness needed to be subpoenaed the for**
42 **hearing!**

43 **Therefore I requested that the prosecuting attorney and the attorney for the**
44 **court to ask for a rescheduling of the hearing date! Until these critical witness**
45 **and**

2 **evidence could be obtained! I informed them that if they did not then I would file**
3 **my on motion in this regard with the inquest court!**

4 **The Judge Comes Out Of The Closet !**

5 **It appears that the court's attorney informed the judge of my desires as then the**
6 **judge in open court! Exposed that she is an agent for the police and planed to**
7 **hold a show trial with a sham hearing! This to effect a coverup with the king**
8 **county attorney and his staff the police murder of Patrick in his own home!**

9 **In the furtherance of this coverup not only did the judge refuse to reschedule**
10 **the inquest hearing! But even more outrageous was that she banned me from the**
11 **court! Who ordered that I could not continue acting as my on attorney at this**
12 **inquest hearing! That I had to hire a state bar licence lawyer all of which by law**
13 **are agents of the government! Who on their face do not meet the constitution's**
14 **requirement of loyal assistance of sovereign independent counselors!**

15 **Further I have the absolute right to act as my lawyer in this case! Which they**
16 **did not want! This so that they could effect a coverup of this police murder, a**
17 **sham hearing protected by their bar controlled lawyers! I then filed formal**
18 **motions with the court, to reschedule the hearing, for a change of venue, and to**
19 **disqualify this judge for Just cause.**

20 **Further in my briefs I submitted the evidence of the Derheims conspiracy to**
21 **steal Patricks inheritance! That they had made the Kent police their agents! Who**
22 **on their behalf came illegally came to Patricks home and murdered him! I further**
23 **submitted evidence to the court of the coverup by the police & the king county's**
24 **prosecutions attorney and his staff!**

25 ***The Indisputable Evidence Of Their Guilt***

26 **While at all times my relationship with the courts probate lawyers (Who Were on**
27 **fact the county attorneys staff) was professional! It became apparent that my**
28 **formal request for additional discovery, and my submitting evidence to the court**
29 **was going to be denied! I informed them that if the county prosecuting attorney**
30 **did not file this motion to obtain this additional discovery and for witness! I**
31 **would file the motions myself!**

32 **Outrageous Conspiracy To Obstruct Justice**
33 **And the Courts Truth Seeking Duties!**

34 **Then Shockingly without any notice, warning or permission the los Angeles**
35 **police officers showed up at my office! Who informed me that they were sent**
36 **here on behalf of the King County Prosecuting attorneys and their Sheriffs**
37 **Department! They said that their mission in part was to find out where I lived!**
38 **What I looked like and was I coming to Washington state for the inquest hearing!**

39 **This when at all times they had my official and email address including my office**
40 **phone number! Which they had called many times an there was no problems and**
41 **no complaints regarding my commutation with them! In fact the day before the**
42 **police came to my office I receive a recent email from the courts attorney Maggi**
43 **Qerimi who provided me with information on the inquest hearing!**

1 However these police informed me that they were here to order me to stop
2 sending the King County Prosecuting attorneys and courts anymore email
3 evidence and discovery! That they had been provided a copy of my professional
4 legal discovery report that I has sent to the courts attorney! Which was to
5 prejudice these police against me as they had no lawful authority to appear at my
6 office an by their very presence to intimidate me! !

7 This by informing them that I had complained that kent police were killing
8 civilians and had murdered Patrick which was none of their concern! As it had
9 nothing to with them other than to prejudice them against me and get them to
10 come to my office for them! As the LAPD also had their share of unjustified
11 shootings!

12 Which was on its face an effort to threaten and intimidate me from sending
13 them information on the Derheims and their kent police agents who had murder
14 Patrick in his own home! This so that they and the court could further their
15 coverup have plausible deniable and conduct a sham show trial hearing! This to
16 protect the police murders of Patrick Reddeck!

17 **THE HEARING ON ITS FACE ILLEGAL NON BINDING**
18 **A DELIBERATE FRAUD UPON THE PEOPLE AND THE COURT**

19 The indisputable facts are that the inquest hearing was on its face illegal. Non
20 binding an a fraud! With deliberate acts of obstruction of justice with the
21 outcome being fixed & predetermined! While critical information of the police
22 killing of Patrick was being suppressed and deliberately withheld from the
23 inquest jury and the people of Washington state!

24 Which was nothing more than a show trial and a cover up! As this court
25 deliberately bared the only Free Pro Per and independent attorney from taking
26 part in this hearing! An the most knowledgeable person in this investigation Dr
27 Edward Reddeck! Who this court had illegally bared from having any
28 involvement in this hearing!

 While failing to notify Patrick's mother of this hearing date! Who has
indisputable evidence in this case as she was the last family member to speak
with Patrick Reddeck before his murder! By the Kent police who had received
from him invaluable evidence of the conspiracy to steal his inherence with amys
parents the Derheims and the Kent Cops that resulted in his death

 This to also prevent Dr Edward Reddeck from exposing this murder and the
betrayal of the most fundamental laws by any civilized people! Therefore on its
face the hearing was illegal and a fraud on the court an the people additional
evidence of this betrayal is aa follows!

 Judge Susan Mahoney, King Country prosecuting Attorney Dan Satterberg
aided by his assistant prosecuting Attorney Maggi Qerimi With the knowledge of
the lawyers for the city and police ! Aided the court in giving an illegal court order
to further this cover and to obstruct justice!

 This order was that I had to stop acting as my on attorney in this case and hire
a state bar licence lawyer (Who would help them effect a coverup) This in wanton

1 violation of the rule of law! The constitutions commands for Justice! An the
2 deliberate violation of the U.S. Supreme Court controlling law in HANES V
KERNER 404 U.S. 519 (1972) and related laws !

3 King Country prosecuting Attorney Dan Satterberg Conspired with the King
4 county sheriff department! Both of who have a conflict of interest as they have
5 been covering up the police killing of civilians. By their pattern practice and
6 custom of conducting sham investigations and then holding show trials! While
withholding the truth from the various inquest hearing judges and juries to
protect their police!

7 Their intent also was for the purpose of stopping me from putting anymore
8 evidence into the record! Of their criminal and treasons acts for the people,
9 press and appeals court to be able to see! Also to prevent me from personally
appearing at this inquest hearing and providing evidence of their coverup and
wanton obstruction of justice!

10 This hearing on its face was illegal and a fraud as it was conducted exclusively
11 by state bar licence lawyers! Those being the judge, the citys/police lawyers, and
Country prosecuting Attorney! Who worked one with another to deceived the
people with sham show trial who committed and suborned perjury !

12 The proceeding further was held without a hearing on my motions that were
13 pending before the court as required by law! An additional coverup for the Violent
14 overthrow of Paticks rights and his murder by the police! The evidence also
15 indicates That the police and the lawyers suborned or committed perjury and
perpetrated a fraud on the court and in their testimony that Patrick had a gun !

16 This deception further aided and abetted by the courts lawyer Maggi Qerimi who
17 ask the cop the leading question (were you afraid when you alleged to have seen
18 patricks gun)! She ask no question of Patricks terror of waking up and hearing
the cops acting like terrorist attempting to kick down his front door!

19 Further as a reasonable man/woman would have to agree that as Patrick
20 peacefully let these three cops in to his home! Even after they attempted to kick
21 down the door to his home! If he had a gun and planed to use it he would have
22 shot them! Before he allowed then into his home, or as soon they came through
23 the door as the terrorist and murders that they were proven to be which he did
not do!

24 He had no gun as when these police came into his home! One cop already had
25 his gun drawn! This even though the day before they were at his home no
26 problem! He opened the door and peacefully allowed hin into his very small living
room!

27 The record in fact shows that he had no gun on him! As the police did not tell
28 him to put the gun down but instead told him to sit on his couch! Then being the
hit team one cop shot him a couple of times at point blank range! Who's wounds
were so serious that he fell to the floor keeping both hands on the alleged gun!

My experts have told me that when a person is shot and falls down they drop
everything in their hands to catch their fall! Then as these cops who were only
inches away from him! When they alleged that Patrick fell on the floor mortally
wounded! He still had both hands on this gun !

1 If this were in fact true they could quickly stepped on this mortally wounded
2 peaceful civilian hands and took the gun away from him or kicked it out of his
3 hands! But they did not they just loaded him up with 13 deadly bullets to make
4 sure he was dead! For dead witness tell no tales and can collect no inheritance .

5 Their allegations of him having a gun was fabricated and manufactured as was
6 their alleged search warrants! Which we have the evidence that they were placed
7 in the courts records after their illegal murder of Patrick in the effort to further
8 their cover up of his cold blooded murder!

9 This hearing was on its face a conspiracy to obstruct justice and coverup for
10 the illegal police conduct! Who were working as the agents for the Derheims
11 aided by their state bar licenced lawyer *Corry Mc Bride!* An their murder of
12 Patrick Reddeck was to steal his money & property which this sham hearing was
13 a coverup!

14 Patricks Mother Ms Craig was not notified by the district attorneys or the
15 courts! That she also had a right to be at the hearing and as a material witness in
16 this case as she had spoken personally with Patrick shortly before his murder by
17 the Kent police!

18 Which furthered the wanton violation of Patricks an my rights under color of
19 law and government authority! Which was part of their racketeering enterprise
20 conducted by the legal establishment and their state bar licence lawyers an the
21 Derheims who conspired to steal patricks inheritance!

22 Who also were aided by the Boeing employees credit union! Who the Derheims
23 gave stolen money to! Which was obtained from the criminal sale of patricks and
24 amys home! This is the same bank who obstructed our investigation and to this
25 day has refused to provide us with any information on his bank records or money
26 in his account at his death or his in business account!

27 Also working in collusion with the police to further their coverup & acts of
28 obstruction of Justice! Involved in this criminal conspiracy and coverup is the
29 Securian life insurance company! Where Amys life insurance policy had made
30 Patrick her sole beneficiary! Who had been directly working with the police to aid
31 then into not paying Patrick his life insurance policy before the police murdered
32 him!

33 They are even withholding all information on this policy, from patricks heirs
34 including its value! *Who also have willful refused to even send the required forms
35 necessary to make the payment to patricks heirs! This in a further effort to aid the
36 Derheims steal this part of his inheritance! Which has been aided by the kent
37 police and this court! The coverup actions are proven by the courts own records
38 in this case!*

39 An Ex Party Emergency Demand For Rehearing !

40 Petitioner moves this court for the following relief an Ex Party Emergency
41 demand for rehearing of the sham show trial of inquest hearing! Which is not
42 time bared based on the fraud upon the court, newly discovered evidence an the
43 following additional information !

44 (1) The hearing was on its face illegal with the outcome fixed and
45 predetermined

1 a deliberate show trial hearing! That was designed to deceive the people in
2 Washington state, Kent and king county ! With a coverup of the custom and
3 indisputable evidence of the local, state and national police deliberate killing of
4 civilians!

5 (2) Judge Susan Mahoney, King Country prosecuting Attorney Dan Satterberg
6 aided by Maggi Qerimi had the court give an illegal court order that I had to stop
7 acting as my on attorney in this case! This was on its face an act obstructing
8 justice as well as the compounding of the conspiracy to violate my right under
9 color of law!

10 THE FACTS ARE ! As the Supreme Court noted that "[i]n the federal courts, the
11 right of self-representation has been protected by statute since the beginnings of
12 our Nation. Section 35 of the Judiciary Act of 1789, 1 Stat. 73, 92, enacted by the
13 First Congress and signed by President Washington!

14 One day before the Sixth Amendment was proposed, provided that 'in all the
15 courts of the United States, the parties may plead and manage their own causes
16 personally or by the assistance of counsel.'"[5] Further the courts are not owned
17 by state bar licence attorneys or any group of lawyers but serve at the pleasure of
18 we the people!

19 This type of betrayal by the Washington state lawyers and its judges! Is the
20 very reason the Founding Pioneers Of America outlawed the practice of law for
21 money made it a Criminal Act! Which we need to re-visit this law for the
22 preservation of our personal and national liberty from these state bar licence
23 lawyers!

24 Further as any State Bar Licence lawyer knows the that U.S. Supreme Courts
25 rulings are the supreme law for every lawyer and court in America! Who's
26 controlling laws on non professional lawyers in any court! Is that they are not to
27 be obstructed from our courts but instead! Are to be admitted into any court and
28 are not even to be held to the standards of a practicing state bar licence attorney!
See HANES V KERNER 404 U.S. 519 (1972)

(3) King Country prosecuting Attorney Dan Satterberg Conspired with the King
county sheriff department To shut me up as a lawyer and a witness in this murder
case! Through threats & acts of intimation from presenting evidence an being a
witness on this criminal and its treasons coverup! This by sending the Los
Angeles police to threaten and intimidate me in a total police state actions ! See
Exhibit A Complaint to lapd!

(4) The inquest hearing was on its face illegal and a fraud as it was conducted
exclusively by state bar licence lawyers that also being the judge, the cities
lawyer, and Country prosecuting Attorney! Who worked one with another to
deceived the people with sham show trial hearing!

All of which have a conflict of interest as they and all the agencies involved
have the interest to save these government individuals and agencies involved!
From the disclosure of their illgal acts and untold millions of dollars in damages!

(5) The proceeding further was committed without a hearing on my motions
pending before the court!! Which was another act in the coverup of the Violent
overthrow of Patricks rights and his murder and by extension all the people in
King

1 county and the state of Washington! !

2 (6) The having of this hearing was on its face a sham, a conspiracy to obstruct
3 justice and coverup for the illegal police conduct. The fact are that at all times
4 the police were working as the agents for the Derheims & their lawyer *Corry Mc*
5 *Bride* ! Who's illegal acts resulted in the murder of Patrick in his own home! As
6 well as the the criminal theft of his money, property, computers and their
7 destruction of his computer business !

8 (7) In this case these state bar licence lawyers through acts or admissions have
9 knowing and willing committed frauds upon the court caused and allowed the
10 police to make false and misleading statements in their initial crime scene
11 investigation report an at the inquest hearing!

12 Where the court deliberately obstructed me from being at this hearing! Even
13 though they knew that I had the indisputable evidence! That the King Country
14 prosecuting Attorney Dan Satterberg and the judge of this court and the legal
15 establishment! As custom obstruct justice who as members of the legal
16 establishment as their custom! One lies about facts and laws while the others
17 swear to it as demonstrated throughout this case !

18 While Displaying the wanton violation of the most fundamental laws of this or
19 any civilized nation with their indisputable criminal act Whos act and coverups
20 are proven by the courts own records in this and other cases. Which is a clear
21 and present danger for all in the state of Washington and specifically King
22 county! It is urgent now and the public safety and security demands that justice
23 be restored and our temples of justice be cleansed !

14 Prayer For Relief

15 Therefore as the result the above facts petitioner request the following relief !

16 (A) Whereas the inquest hearing was illegal and a fraud upon the court as an
17 division of the government people in the state of Washington! That was aided and
18 abetted by the state bar licence lawyers officers of the court which includes the
19 presiding judge of this case! Therefore as the hearing was a fraud, invalid and
20 illegal and must be set aside!

21 (B) That this case and that of the probate fraud be transferred to a new court
22 outside of king county and assigned to a the states attorney general , special
23 prosecutor, and to a federal court! An a new hearing scheduled where due
24 process, equal protection! The court truth seeking process & the requirements of
25 justice can then be served! An the peoples rights, safety and security can be can
26 be protected!

27 (C) That a copy of all records including personal notes from this investigation
28 by Kent, Alburn and Federal Way police departments! Their agents be produced
under penalty of perjury and criminal contemp of court if not provided !

(D) The Complete Paramedic Report crime scene pictures, cell phone
transmissions, and all personal records be discovered !

(E) A copy of total docket file and records for all the inquest hearings including

1 the last one be produced !

2 (F) The video camera from patricks home, its recordings including those stored
3 on his computers and his cell phones!

4 (G) Records from all amys work, her computers and her cell phones!

5 (H) The Copy of the recording or transcripts of all court hearings in his case be
6 provided!

7 (I) A Copy of all records in the police custody including those from Patricks
8 computers that they stole over a year ago when they murdered him be produced !
9 Who have refused to return to his heirs to this day deliberate obstruction of
10 justice and this investigation!

11 (J) A list of all those who in the county attorneys office and sheriff's
12 department authorised the contact with the lapd! To have them make terrorist
13 threats against me to stop my investigation! An to prevent me from providing
14 additional evidence to the county attorneys office, the inquest courts attorney ,
15 the court and the jury See Exhibit A !

16 (K) That as the result of the terrorists threats against myself, family, friends and
17 business associates by the king county attorney Dan Satterberg and their
18 sheriff's who were responsible for the police Murder of my son Patrick and its
19 coverup! Who to further their coverup they illegal contacted the Los Angeles
20 police and sent them on a mission to use their office and authority for the
21 purpose of the obstruction of justice!

22 An to use their presence and official authority to intimidate me! As the result I
23 now fear for my safety and those of my friend, family, and business associates!
24 Therefore in the future there will be allowed no personal contact with me or
25 anyone connected to me by anyone directly or indirectly connected to this case!
26 That all commutation must be in writing! Any other contact will be considered a
27 additional threat and filed with state and federal law enforcement authorities for
28 their action!

(L) That a copy of all written an verbal commination with the Los Angeles
police and their response be provided!

(M) As petitioner has while acting as the pro per attorney in this case has
spent much time in investigation and legal research for the peoples inquest
hearing providing and invaluable service to the people of king county ! Where as
the county and city has hired expensive private attorneys to suppress the truth
about the police at this hearing! It is only just that I get payed for my services as
well! Therefore let me know where I should send my invoices!

(N) To make sure that my billing is inline with those of the governments
professional lawyers! I request that you send me a copy of their total billing and
their hourly rates !

(O) Any Further Compounding this conspiracy! It is my advice that all involved
in this conspiracy now take steps to militate the damages and contact your
private attorneys or one of over the two hundred bar lawyers in the counties
attorneys office!

1 **Who also may have an incurable conflict of interest who should obtain counsel**
2 **on the law that holds that even the smallest act in the furthering of this**
3 **conspiracy makes them under law guilty of the entire conspiracy from its**
4 **beginning!**

5 **The indisputable evidence is coming in from all over this state and in this**
6 **courts own records of this betrayal by these state bar licenced lawyers & their**
7 **accomplices! Those with additional information this on betrayal government or**

9 **(P) With this notice I amend to this motion all previous court fillings and**
10 **records in this case and all other probate case filings!**

11 **(Q) All other relief that is allowed by law, justice equitly and the rulings of this**
12 **honorable court!**
